Information requiring attention

- The Lessee Compensation Plan (hereinafter referred to as the Plan) is provided free of charge to members of iSmilePlus (hereinafter referred to as the Service) as insured persons (insurance beneficiaries) in accordance with the non-life insurance contract concluded by and between iThinkRent as the policyholder and Chubb Insurance Japan (hereinafter referred to as Chubb).
- The insurance policy of the Plan is kept by the policyholder and not delivered to the lessee.
- Customers may separately take out fire insurance depending on the actual condition of their household goods. For more
 information, please contact us using the contact details below.
- Compensation under the Plan will start from the date of acquisition of membership or the date of move-in, whichever is later, and will end in the following cases.
 - · When the Service is terminated.
 - When the customer ceases to be a member.
 - When the rented room is used for purposes other than residence.
- The insurance premiums for the Plan are borne entirely by the policyholder. No insurance premiums are borne by the contracting party under the lease contract or the resident.
